Case #1-2022, 150 West Argonne Drive (Landmark #77, Heinzelman Bakery Building, Downtown Kirkwood National Register District) – Partial demolition, alterations and additions for 4 Hands/Down by the Station restaurant and outdoor use project. Revised caboose, restroom and new overhead structure details.

- b. Case #4-2022, 415 Scott Avenue (Landmark #23, World's Fair Wisconsin House, East Monroe National Register District) – Partial demolition, alterations and additions concept plan.
- c. Case #5-2022, 208 E. Bodley Avenue (North Taylor Historic District) New in-ground pool.
- d. Case #6-2022, 341 E. Jefferson Avenue Drive (Jefferson-Argonne Historic District) New house and detached garage on vacant lot.

Landmarks Commission Work Session Minutes Wednesday, January 12, 2022, 6:00 p.m. Via Zoom Virtual Meeting

Pursuant to notice of meeting duly given, the Landmarks Commission convened via a Zoom virtual meeting. Present: Chair Ryan Molen, Commissioners Judith Brauer, Nancy Luetzow, Robert Rubright, Jessica Worley, and Staff Liaison Amy Lowry. The meeting was called to order at 6:05 p.m.

Chair Molen stated for the record that Section 610.015 of the Mo. Sunshine Law provides that members of the Landmarks Commission who are not physically in the Council Chambers can participate and vote on all matters when an emergency exists and the nature of the emergency is stated in the minutes. Certificates of Appropriateness – Unfinished Business

- a. Case #23-2021, 324 North Taylor Avenue (North Taylor Historic District) The Commission still has questions regarding the height of the fence, but otherwise the applicant addressed earlier comments for the in-ground pool.
- b. **Case #25-2021, 601 E. Jefferson Avenue** (Jefferson-Argonne Historic District) The Commission discussed the improved scale of the new detached garage.

Certificates of Appropriateness – New Business

- a. Case #1-2022, 150 West Argonne Drive (Landmark #77, Heinzelman Bakery Building, Downtown Kirkwood National Register District) With regard to the partial demolition, alterations and additions for 4 Hands/Down by the Station restaurant and outdoor use project, the Commission discussed the address wall in front of the caboose, the trash enclosure, the railcar restroom, and the changes to the building itself.
- c. **Case #2-2022, 145 Horseshoe Drive** (Sugar Creek Ranch Historic District) The Commission discussed the detached pergola and had no major issues.
- d. Case #3-2022, 345 East Argonne Drive (Landmark #8, Tallhurst-Burr House, Jefferson-Argonne Historic District) With regard to the demolition of rear addition, new 2-story rear addition, and new foundation for original house, the Commission recognized that changes had been made in response to earlier Commission comments.
