

## City Council Meeting Minutes Kirkwood City Hall Thursday, March 2, 2023, 7:00 p.m.

Pursuant to notice of meeting duly given by the Mayor, the City Council convened on Thursday, March 2, 2023, at 7:00 p.m. at Kirkwood City Hall, 139 South Kirkwood Road, Kirkwood, Missouri. Present were Mayor Griffin, Council Members Duwe, Gibbons, Luetzow, Sears, Ward and Zimmer. Also in attendance were Chief Administrative Officer Russell Hawes, Assistant Chief Administrative Office David Weidler, City Clerk Laurie Asche, Deputy City Clerk Bridget Waters, Planning and Development Services Director Jonathan Raiche, Director of Finance Sandy Stephens, Assistant Director of Finance Jennifer Forgy, Director of Electric Mark Patty, Director of Public Works Bill Bensing, and City Attorney John Hessel.

#### **COMMENTS FROM MAYOR GRIFFIN**

Mayor Griffin made a statement that Council meetings will always be respectful and show civility. The Council will not tolerate any disrespect or incivility. Comments that were made by Council Member Ward during the last meeting were inappropriate and directed to a staff member. Mayor Griffin apologized to Director of Public Works Bill Bensing and to staff for those comments made.

Council Member Ward stated that his remarks during the last Council meeting were not intended to disparage Bill Bensing's performance as Director of the Water Department. Council Member Ward went on to say that as a Council Member, he hopes to always create a positive change for the residents and the employees.

#### **PUBLIC HEARINGS**

Mayor Griffin recessed the meeting for the purpose of conducting a public hearing regarding a request for a Zoning Code text amendment related to parking requirements for outdoor dining areas for restaurants. Mr. Hessel entered the following exhibits into record: an Affidavit of Publication in the St. Louis Countian on February 10, 2023, as Exhibit 1; an Affidavit of Publication in the Webster-Kirkwood Times on February 10, 2023 as Exhibit 2; Memorandum from the Planning and Zoning Commission with exhibits dated February 1, 2023 and as amended by the Planning and Zoning Commission on February 1, 2023, as Exhibit 3; a report from the Planning and Zoning Commission with a vote of 8-0 recommending staff approval initiated zoning code text parking requirements for outdoor dining areas dated February 2, 2023, as Exhibit 4; and the Kirkwood Code of Ordinances, as Exhibit 5.



Director of Planning and Development Services Jonathan Raiche presented the matter to the Council:

- Over the past year, staff has been approached by multiple existing and potential property and business owners that have expressed a desire to either add or expand outdoor dining areas for restaurants for businesses in downtown Kirkwood.
- Currently the City of Kirkwood code does not have any parking requirements for the reuse of existing buildings in the downtown area
- However, we do require additional parking for new construction in the downtown area, as well as for additions to existing buildings
- Staff differentiate between outdoor seating, which is for 12 seats or fewer and outdoor dining, which is 12 or greater than 12 seats
- 12 seats or fewer, does not require additional parking to be provided
- Outdoor dining greater than 12 seats that is not covered by a roof or enclosed, does not require additional parking
- Some changes to the code are outdoor dining which greater than 12 seats covered by roof, would require additional parking, subject to new exemptions
- The area remains unenclosed, meaning it remains primarily open

A discussion took place. Some of the discussion is as follows:

- Question was raised regarding what would be considered expansion of a building under the proposed amendment? Any wall 42 inches or greater in height and enclosed.
- Question was raised regarding if additional sidewalks will be included?
- Question was raised regarding if any changes to the Zoning Code to allow rooftop seating? If more than 12 seats are being proposed then the issue would come before the Council for a Special Use Permit.

The Bill will be placed on the April 6, 2023 agenda for first reading consideration.

#### **PUBLIC COMMENTS**

1. Jill Caruso, 343 E. Bodley Ave made comments about Bill 10970 and expressed concerns regarding increased traffic on East Bodley.
