# Call Meeting to Order and Approval of Minutes

Acting Chairman, Chris Burton called the meeting to order at 7:00 p.m.

Mr. Burton asked if there were any comments for the November 6, 2023 meeting minutes.

Pat Jones made a motion to approve the November 6, 2023 minutes. Seconded by Dick Gordon. Motion approved unanimously.

Ι. Sign Review- Old Business - None

#### П. Sign Review- New Business

a. 35-23S -575 Couch Ave - R-3

Fastsigns of Webster Groves and Brentwood, applicant - Installation of sign at main window entrance

Isao Salazar addressed the board about the update for the six logo stickers located on the building doors. The board asked questions regarding the color of the new logo, and the existing material of the "505" logo currently on the main door. Mike Marlo made a motion to approve case 35-23S as submitted. Seconded by Dick Gordon. Motion approved unanimously.

b. 36-23S – 516 S. Kirkwood Rd. – R-5 Signcrafters, applicant – Monument installation.

Andrew Moreman addressed the board about updating the secondary sign due to the old age of the sign. Mr. Moreman said the client wanted to incorporate themes from the existing pad in development of the new sign. The board discussed issues with consistency with the new and existing signs.

Mike Marlo made a motion to approve case 36-23S with the following conditions. 1) Use red coloring for the lettering to keep consistent with existing signs. 2) Paint the base green to match the existing sign at the corner of Kirkwood Rd and Woodbine. Seconded by Dick Gordon. Motion approved unanimously.

c. <u>37-23S – 110 N. Kirkwood Rd – B-2</u> AAA Signpros, applicant – Installation of new sign.

Kenton Elman addressed the board about the new sign. Mr. Elman stated that he was made aware of a color change to the building that day. The current owner utilizes similar branding with five other location in the state of Missouri. The board addressed concerns with the visibility of the lettering, and cookie shape with the red coloring of the building.

Pat Jones made a motion to approve case 37-23S with the following conditions: 1) Change main coloring to white. Seconded by Dick Gordon. Motion approved unanimously.

# III. Residential Review- Old Business

a. <u>141-23R – 531 N Crescent – R-3</u>

NJL Custom Homes, applicant – Construct new single family home, revised drawings to respond to suggestions after continuance at last meeting.

Peter addressed the board about the corrections made to the plans of the home. The board had concerns with the stone material return on all four corners. Dick Gordon made a motion to approve case 141-23R with the following conditions: 1) For the garage, stone be returned on all four corners. For the rear elevation of the garage, the stone can stop at the person door. Seconded by Don Anderson. Motion approved unanimously.

## IV. Residential Review- New Business

a. <u>148-23R -333 George – R-4</u>

FM Design Build, applicant – Construct new single family home.

Matt Moore addressed the board about constructing a front facing garage with a modern look. The board discussed the size of the patio door and Mr. Moore confirmed the 12 ft. width of the door. In addition, adding windows that are the same size of the existing windows, and adding sills and aprons.

Don Anderson made the motion to approve case 148-23R with the following conditions: 1) Including fixed paned window in stairwell on the right side elevation. On the right elevation, the window in the stairwell to be the same size (in terms of height) as other windows. Can be two doublehung windows or two casement windows. 2) Adding sills and aprons onto

# the windows of the house. Seconded by Pat Jones. Motion approved unanimously.

 b. <u>149-23R – 680 Craig Woods Dr. – R-3</u> Tim McMennis, applicant – Deconstruct old deck rails. Constructing new rails.

The applicant was not present for the meeting. The board had no comments. **Mike Marlo made the motion to approve case 149-23R as submitted. Seconded by Dick Gordon. Motion approved unanimously.** 

c. <u>150-23R – 1050 Couch Ave – R-3</u> Rombach Development, LLC, applicant – Construct new single family home.

William Rombach addressed the board. The board discussed issues about the blank right and left side elevations. The stone material being returned on each side of the home. Changing gables to match the rear and sides with the front of the home.

Don Anderson made the motion to approve case 150-23R with the following conditions. 1) On the left elevation, having a total of 2 windows in the garage, not just 1. 2) On the left elevation, adding a window in the walk-in closet of bedroom #2. 3) On the rear elevation, adding a window in the walk-in closet of bedroom #3. 4) On all gables, have rake boards and band boards.5) On all side gables, also have board and batten. 6) Adding 2 foot stone returns on each side of the house. Seconded by Dick Gordon. Motion approve unanimously.

 d. <u>151-23R – 208 W. Rose Hill Ave – R-4</u> Solera Energy LLC (Maricar Clementir), applicant – Solar panel installation/roof mount.

John with Solera Energy addressed the board. The board questioned the age of the roof, and if it would be replaced before the solar panel install. The applicant confirmed that the roof is three years old.

Mike Marlo made the motion to approve case 151-23R as submitted. Seconded by Dick Gordon. Motion approved unanimously.

e. <u>152-23R – 10434 Big Bend Rd. – R-4</u> Richard Moreland, applicant – Enclosing shed

Richard Moreland addressed the board. The board asked about the orientation of the garage and the material of the proposed siding. Pat Jones made a motion to approve case152-23R as submitted with the following conditions. 1) Garage door windows be added to the front and rear of the structure. 2) Siding material matches the rest of the house. Seconded by Dick Gordon. Motion approved unanimously. f. <u>147-23R – 952 Lanyard Ln. – R-4</u>
 Agape Construction, applicant – Removal and rebuilding of existing porch.
 Adding new windows and sliding door.

Taylor Houston addressed the board about a porch remodel. The client wants to make the structure more proportional to the current house. The board discussed issues with window trims and material consistency. Don Anderson made the motion to approve case 147-23R with the following conditions. 1) New windows need to match the existing house. Seconded by Dick Gordon. Motion approved unanimously.
