Landmark Sign Company, applicant – Window sign install.
The board had no comment.

- a. 47-22R 341 E Jefferson – R3
William Cover, architect; applicant – Removal of limestone band between floors in front elevation in previously approved plans for new single family residence.

Josh Peterman, applicant – resubmission: window changes for new home.
The board discussed adding a transom window to the pantry, and increasing the size of the windows in the kitchen area.

Roeser Home Remodeling, applicant – Home remodel, with rear addition

The board discussed adding widows to the garage door, and a second window to the mud room on the left side elevation.

Kingbridge Homes, LLC, applicant - New home construction
The board discussed adding windows to the pantry on the right side elevation. Bringing the stone material down to align with the window sill. Lastly, adding stone to the garage to match the front of the house.

The board discussed filling the blankness of the wall on the rear elevation with a window. Adding band and board to the top rear left. Extended the front gable, and adding a transom window to the 2nd floor bathroom.

The board discussed the condition of the roof.
