Motion was made by Council member Sears and seconded by Council member Luetzow to bring Substitute Bill 11017 to the floor. Motion was unanimously approved.

Substitute Bill 11017, authorizing the City of Kirkwood, Missouri, to enter into a Lease Purchase Transaction, the proceeds of which will be used to pay all or a portion of the costs of acquiring certain property, constructing improvements within the City and other costs related thereto; and authorizing the execution of certain documents and actions in connection therewith was brought before the City Council. A discussion took place.

The bill, having received majority approval of the Council, was adopted and became Ordinance 10844.



NEW BUSINESS

Bill 11018, granting a Special Use Permit for Drive-Through Facility for Restaurant and approving the B-5 Final Site Plan Amendment at the property known as 1147 South Kirkwood Road, subject to certain conditions was brought before the City Council. Motion was made by Council Member Duwe and seconded by Council Member Zimmer to accept the bill as read.

Motion was made by Council Member Gibbons and seconded by Council Member Luetzow to amend Bill to add subsection 22 under Section 1 which would read, "Prior to the issuance of permits, a revised final site plan shall be submitted that extends the proposed 5' wide internal walkway along the eastern edge of the proposed parking field." The motion to amend was unanimously approved.

Motion was made by Council Member Sears and seconded by Council Member Zimmer to suspend Roberts Rule of Order to allow the petitioner to address the Council. The motion was unanimously approved. A discussion took place.

The amended bill received first reading approval and was held over.

Bill 11019, granting a Special Use Permit for an Animal Facility, Major at 10328, 10330 and 10332 Manchester Road (Greentree Center), subject to certain conditions was brought before the City Council. Motion was made by Council Member Zimmer and seconded by Council Member Duwe to accept the bill as read.

The bill received first reading approval and was held over.

Bill 11020, amending the provisions of the Municipal Code, Chapter 25 – Zoning and Subdivision by changing the Personal and Commercial Service Use from Special to Permitted in the I-1, Light Industrial District was brought before the City Council. Motion was made by Council Member Zimmer and seconded by Council Member Duwe to accept the bill as read.

Motion was made by Council Member Luetzow and seconded by Council Member Zimmer to amend Bill 11020 by amending the title to state "An Ordinance amending the provisions of the Municipal Code, Chapter 25 – Zoning and Subdivision by changing the Personal and Commercial Service Use from Special to Permitted in certain areas zoned I-1, Light Industrial District", and to strike the language in Section 1 in the proposed ordinance and replace it with a new Section 1, to add a new Section 2, and to renumber the existing Section 2 as Section 3, with the language as follows:

"SECTION 1. That the City of Kirkwood Municipal Code of Ordinances, Chapter 25 – Zoning and Subdivision Code, Article III Zoning Districts and Principal Uses, Table 35-1, row "Personal and commercial service" and column "I-1" is hereby amended by adding letters "PS/" in front of "S", to change this use category as "PS/S" for permitted with standards/special use."



"SECTION 2. That the City of Kirkwood Municipal Code of Ordinances, Chapter 25 – Zoning and Subdivision, is hereby amended by deleting subsection (y) in Section 25-36, Use –Specific Standards, in its entirety, and replacing it with the following language:

(y) Personal and commercial service.

(1) In the B-1 and B-2 Districts, the maximum size of any tenant space shall not exceed 2,000 square feet.

(2) In the I-1 District, such use is permitted only on lots with frontage or addresses on South Kirkwood Road, Grand Avenue and Prospect Avenue. On all other I-1 zoned lots, such use shall be a special use requiring approval through the special use permit review procedure." The motion to amend was approved with Council Members Duwe, Gibbons, Luetzow, Wurtz, and Zimmer in favor and Mayor Griffin, and Council Member Sears opposed."

Motion was made by Council Member Sears and seconded by Council Member Luetzow to suspend Roberts Rule of Order to allow the petitioner to address the Council. The motion was unanimously approved. A discussion took place.

The amended bill received first reading approval and was held over.

Bill 11021, amending Chapter 4, Animals and Fowl, Section 4-9 of the Municipal Code of Ordinances, to provide an exception for Service Animals was brought before the City Council. Motion was made by Council Member Duwe and seconded by Council Member Zimmer to accept the bill as read.

The bill received first reading approval and was held over.

Bill 11022, approving the Preliminary Plat and Final Plat for a Major Subdivision at the properties known as 111 W. Rose Hill Avenue and 711 S. Kirkwood Road, and approving two modifications to the Subdivision Design Standards in Chapter 25, Article X of the Municipal Code of Kirkwood, subject to certain conditions was brought before the City Council. Motion was made by Council Member Duwe and seconded by Council Member Luetzow to accept the bill as read. A discussion took place.

The bill received first reading approval and was held over.

Resolution 7-2024, authorizing and directing the Mayor to enter into a Mutual Aid Agreement with the Missouri Public Utility Alliance for mutual aid resources for the Electric Department was brought before the City Council. Motion was made by Council Member Duwe and seconded by Council Member Luetzow to accept the Resolution as read. A discussion took place.
