## I. Call Meeting to Order and Approval of Minutes

## a. 17-24S 11149 Manchester Rd- B3

Excel Signs & Design, applicant – Installation of mounted wall sign for Telle Tire and Auto Center Kara Neubauer of Excel Signs presented the proposal to the Board. The Board confirmed the color of the raceway would match the wall.

Mr. Marlo made a motion to approve case 17-24S as submitted. Seconded by Mr. Burton. Motion approved unanimously.

## V. Residential Review - Old Business

## a. <u>25-24R 111 W Rose Hill – R5</u>

Tony Camacho, applicant – Resubmittal: interior remodel and addition Mr. Camacho was not present. The Board had no comments and were not concerned with approving it without the applicant present. Mr. Camacho showed up to the meeting a little while later and the Board informally discussed the proposal at the close of the meeting.

Mr. Burton made a motion to approve case 25-24R as submitted. Seconded by Mr. Chiodini. Motion approved unanimously.

#### VI. Residential Review - New Business

### a. 65-24R 536 Linwood Blvd - R4

Eagle Contracting, applicant – Bedroom addition

Ray Joseph of Eagle Contracting presented the proposal to the Board. He noted the siding around the entire house will be redone to match the addition's LP smart siding. The new roof shingles will match the existing and the windows will match the existing.

Mr. Burton made a motion to approve case 65-24R as submitted. Seconded by Mr. Garware. Motion approved unanimously.

#### 68-24R 224 Woodridge Rd – R4

Bopp Instruction, applicant – Carport replacement

Sydney Logan presented the proposal to the Board. The Board discussed the need for more ornamentation on the columns and had questions about the roofline.

Mr. Gordon made a motion to approve case 68-24R with the following conditions: 1) Add base and cap to columns, and 2) add vent to west elevation. Seconded by Mr. Burton. Motion approved unanimously.

## c. 72-24R 1312 W Essex - R1

John Odom, applicant - Construction of a new single family home

The architect Mr. Odom presented the proposal to the Board. They discussed the front porch roof, how the front porch foundation would be covered with stone to prevent too much exposure, and the use of board and batten in the gable.

Mr. Burton made a motion to approve case 72-24R with the following condition: 1) windows must have sills and aprons per City guidelines. Seconded by Mr. Marlo. Motion approved unanimously.

#### d. 73-24R 532 S Fillmore Ave - R4

Axton McCormack, applicant - Two story framed new built

David Molner presented the proposal to the Board. The Board had questions about the stone material used.

Mr. Chiodini made a motion to approve case 73-24R as submitted. Seconded by Mr. Burton. Motion approved unanimously.

## e. 74-24R 441 Gill Ave - R3

Hercules Design Build, applicant - Rear addition and covered deck

The applicant and the Board discussed the best way in which to tie in the roof of the addition to the existing house. They came to the conclusion that the current proposal was the best way to address the issue.

Mr. Burton made a motion to approve case 74-24R as submitted. Seconded by Mr. Gordon. Motion approved unanimously.

### f. 75-24R 316 McCullough - R4

Jennifer Sims Taylor, applicant – Remove existing deck, build new covered deck Adam Schmitz from Terra Nova Builds presented the proposal. The Board discussed the type and color of materials used in the railing system as well as the structure of the posts.

Mr. Anderson made a motion to approve case 75-24R with the following conditions: 1) add bases and caps to lower deck posts, and 2) add fascia board to the area between grade and the deck to the right of the retaining wall. Seconded by Mr. Gordon. Motion approved unanimously.
