Committee Reports

Sculpture on the Move - No written report at this time. I'll have an update on the installation of the three sculptures.

Photo Contest – Agnes and/or Jim can report on the contest.

Art At the Station – Zoe and Will (who is the resident artist this month) can report on schedule changes and other events.

Making Music – Gary can report on updates to the lineup and other issues related to the concert series, as well as plans for next year.

Arts Foundation – Art McDonnell can report on any actions of the Foundation.

Unfinished Business

<u>Strategic Planning Update</u> – This agenda item is an ongoing entry to the agenda. Individuals can report on any actions taken relative to the plan.

Performing Arts Center Mural Project -Further follow up on this project was suggested at the last meeting. I have some pricing information on printing the possible banners along with information about the possible number of possible displays.

<u>Greentree Festival</u> - It may be useful to discuss some of the mechanics of how the booth can be hosted during the festival. A final decision needs to be made on participation in the parade.

New Business

Arts Calendar Criteria – My apologies if we have previously discussed this issue and reached a resolution. Beth Von Behren has asked that she be given direction on what should go in the arts calendar she produces on behalf of the Commission.

Upcoming Fiscal Year Budgets – Via email I have requested that you start preparing budget requests for the upcoming fiscal year. Copies of the current City budget amounts along with budgeting information from the Foundation are included in the packet. It may be useful to discuss who will take responsibility for the various aspects of the budget as well as any ideas regarding additional budget needs.

Kirkwood Art Commission Meeting Minutes June 25, 2019

PRESENT: Zoe Perkins (Chair), Agnes Garino, Jim Erwin, William Frank, Glenda Hares, Gary Hochberg, Andrew Smith, Deanna Stevenson, Stefanie Murray Pounds (Staff Liaison) EXCUSED: Jim Weidman, Art McDonnell

Chair Zoe Perkins called the meeting to order at 5:10 p.m. Murray Pounds was designated to take the minutes for this meeting.

CITIZEN COMMENTS

There were no citizen comments.

APPROVAL OF MAY 21, 2019 MINUTES

Motion made by Agnes Garino, seconded by Jim Erwin to approve the May 21, 2019 minutes as presented. Motion carried unanimously.

COMMITTEE REPORTS

PUBLIC ART SOMMITTEE: Sculpture on the Move, Murray Pounds reported on the installation of the signs for "Xuberant" and that the installation of "Purple Twist" in Kirkwood Park is complete. The installation of "Cloudcutter" has been delayed until late June. Photo Contest, Jim Erwin reported that eight entries have been received, and an additional 13 people have registered but not entered photos. Agnes reported on efforts to promote the contest. A discussion was held about how to improve participation in the future.

ART AT THE STATION: Zoe Perkins reported that the display by Will Frank will be installed on July 1. Reception will be held on June 10. Agnes Garino commented on the reception for Ron Earsay which included him making comments about his photographs.

MAKING MUSIC: Gary Hochberg reported that the May 15 concert by the Bel Airs was very successful with over \$600 collected from those in attendance. He also reported that the "Little Lunch Music" event featuring performers from Opera Theatre held June 24 was highly successful. Based on the response of the crowd there is a desire for this type of activity to be held in the future.

KIRKWOOD ARTS FOUNDATION: Art McDonnell reported there had been some difficulty in getting the donation from Kirkwood Electric for the concert series, but that has been resolved. The foundation is in the process of sending out letters thanking contributors.

UNFINISHED BUSINESS

STRATEGIC PLANNING: Murray Pounds reported a meeting will be held with the treasurer from the Kirkwood Arts Foundation to establish a budget calendar and responsibilities. He also

reported on a meeting of the PAC Visual Arts Task Force that identified possible locations for fixed art.

Jim Erwin reported on some strategic actions arising from a meeting of the Public Art Committee. They included near term projects to recognize Mel Bay, add signs to welcome those entering the City at its boundaries, and developing a mural at Bisso Park.

Stefanie Kirkland asked of the strategic plan was complete, or if there are opportunities to address concerns about diversity. There was agreement that the strategic plan was an opportunity to bring diversity to the Commission's activities and that it should be an ongoing priority.

CARS AND GUITARS EVENT: It was a very successful event. Thanks to Zoe Perkin's friend Miriam in getting the booth set up. Sales of guitars and beads totaled over \$400. Next year's date for the event is June 13, 2020.

GREENTREE FESTIVAL PARTICIPATION: Booth application has been made for the Commission. Discussion was held regarding participating in the parade. Three members of the Commission have agreed to walk/ride in the parade. Additional participants will be recruited.

NEW BUSINESS

PERFORMING ARTS MURAL PROJECT: Agnes Garino presented a proposal to develop a mural art program that would be displayed on the construction fence at the PAC site. The project could involve various schools' arts programs. Methods of displaying the art were discussed. Agnes and Murray Pounds will report back at the next meeting on how many displays could be accommodated and what costs might be.

FUTURE MEETING DATES: Murray Pounds suggested in order to accommodate the schedules of some of the new commission members the regular meeting date be moved to the fourth Tuesday of the month. This suggestion was accepted.
