IN ATTENDANCE: The meeting was called to order at 5:05 p.m. In attendance were Jim Erwin, Agnes Garino, Glenda Hares, Gary Hochberg, Stefanie Kirkland, Andrew Smith, Deanna Stevenson, Art McDonnell (Ex-Officio) Murray Pounds (Staff Liaison), Excused: Zoe Perkins.

I. CITIZEN COMMENTS - None

II. APPROVAL OF JULY 23, 2019 MEETING MINUTES – A motion to approve the July 23, 2017 meeting minutes made by Agnes Garino, seconded by Glenda Hares. Motion approved unanimously.

III. COMMITTEE REPORTS

- a. Public Art
 - Sculpture on the Move Discussion was held on mounting height for information plaques. Plaques will be set at a lower level. Discussion was held on having some sort of reception for the artists. Agnes Garino will check with artist(s) about appearing in the Greentree Festival booth as part of a "Meet the Artist" effort.
 - ii. Photo Contest Photo Contest entries and winners will be put on display in September at the train station. Receptions will be held September 6th and 10th. Pictures will be relocated to United Missouri Bank at the end of September.
- Art at the Station Will Frank reported the current artist in residence, Jen Mischa, is displaying her photography. Several favorable comments regarding her work were made.
- c. Making Music Concerts Gary Hochberg reported the three concerts held since the last commission meeting were well received. The Southside Creole Playboys were particularly popular. Because of the way the calendar lines up and potential conflicting events, next year's schedule includes one concert in May, June and October and two concerts in July and August.
- d. Kirkwood Arts Foundation Art McDonnell reported the Foundation board will be meeting on September 23.

IV. UNFINISHED BUSINESS

- a. Strategic Planning Update No updates
- b. Performing Arts Center Mural Project Agnes Garino reported there is a lot of interest in the mural project. She expects to have 15 20 murals included in the project. A mural banner indicating the participation of the Arts Commission is to be created. Murray Pounds reported there is adequate funding available in the Arts Commission's account to cover this number of banners.
- c. Greentree Festival Participation Assistance will be needed in setting up the booth. Agnes is coordinating the creation of three posters highlighting Commission activities.





- A question was raised as whether or not the Commission is entered into the parade. Murray will check on that.
- d. Upcoming Fiscal Year Budgets Murray reported on the budget amounts included in the Arts Commission's account. The Making Music Concert budget is completed and ready for submission to the Arts Foundation. Any other budget request for the Arts Foundation should be submitted prior to the Foundation's meeting on September 23.

V. NEW BUSINESS

- a. Possible Purchase of Purple Twist Sculpture Agnes reported the cost to purchase the "Purple Twist" sculpture would be \$3,735. Art McDonnell indicated the Foundation has reserved money for purchase of public art. A decision regarding the purchase will be delayed until next month.
- b. Joint Kirkwood Arts Commission/Arts Foundation Meeting Chair Zoe Perkins would like to set up a meeting between Commission and Foundation members. A tentative date of October 22, the date for the Commission's monthly meeting was set.
- c. PAC Presentation Murray presented a display tracing the history and progress of the Performing Arts Center facility.
- d. Other Matters None.
