Bill 10634, appropriating \$608,000 from the Electric Fund Balance to the Purchase Power Account to fund purchase power expenses for the Electric Department, was brought before the council. - 2. The Commission continued the application to rezone 1837 Bach Avenue from R1 to R2 to the April 4 meeting.
- 3. The Commission approved a Resolution supporting the Downtown Master Plan and Parking Study.
