NEW BUSINESS

Bill 10629, granting a Special Use Permit Amendment and Site Plan Amendment for a convenience/gas store (BP Gas) on property known as 10901 Manchester Road subject to certain conditions, was brought before the council. CITY CLERK REPORT

Ms. Asche read the report of the March 7, 2018 Planning and Zoning Commission meeting. The following action took place:

- 1. After reading the Subcommittee Report recommending approval of amendments to the Site Plan for Trinity Presbyterian Church at 1110 South Glenwood Lane for an addition to the building and expansion of the parking lot, the Commission continued the report to the March 21 meeting to allow the applicant to address storm water concerns raised by residents at the meeting.
- 2. After a presentation to rezone 1837 Bach Avenue from R1 to R2, a subcommittee consisting of Commissioners O'Donnell and Stauder was appointed. The subcommittee will meet on the site March 13 at 8:30 a.m.
- 3. The Commission recommended approval of amending the Zoning Code regarding side yard setbacks in the R3 Zoning District in accordance with the Subcommittee Report dated March 7, 2018. A public hearing will be scheduled.
